Section 1: Establishment Aims

<u>Aims</u>

Our aim is to provide a quality education in a happy and supportive place of learning where pupils are taught the fundamentals of the Catholic faith and learn respect for all other creeds and religions. In co-operation with our parents we hope to enable our pupils to take a useful place in society. In school they are taught to be literate and numerate, develop knowledge about the world and their place in society and to have a knowledge and love of the arts and music. We try to discover and nurture individual talents, develop skills both physical and mental and foster enquiring minds so that children become independent learners.

In personal and social development we aim to help the children develop a healthy attitude to others both in school and in the community; to have respect for themselves, their peers, all adults and all with whom they come in contact irrespective of race/creed or colour.

SPIRITUAL, SOCIAL, MORAL AND CULTURAL VALUES



Religious Education is an important part of the school curriculum. 'This is Our Faith' and 'God's Loving Plan' religious education schemes are used in primaries one – seven. These schemes are approved by the Diocese of Motherwell and aim to give pupils an understanding of scripture appropriate to their age as well as being concerned with the fundamental teachings of the Catholic Church. The Education for Love programme focuses on relationships and moral education. The

Parish Priest is a regular visitor to the school throughout the year. Preparation for the Sacraments of Reconciliation, Holy Communion and Confirmation are integral parts of the programme offered.

Rights of Parents / Carers

Scottish Government Ministers consider that religious observance complements religious education and is an important contribution to pupils' development. It should also have a role in promoting the ethos of a school by bringing pupils together and creating a sense of community.

There is a statutory provision for parents to withdraw children from participation in religious observance. This right of parents' wishes will be respected.

Where a child is withdrawn from religious observance, schools will make suitable arrangements for the child to participate in a worthwhile alternative activity.

Equalities

Integral to this guidance is the principle of mutual respect. The diversity of belief and tradition provides an ideal context in which pupils can learn about, and so learn from, what is important in the lives of themselves and others. South Lanarkshire's guidance recognises and welcomes diversity and promotes respectful understanding.

Parents may request that their children be permitted to be absent in order to celebrate recognised religious events. Advance notice should be provided to the school when children will be absent. Appropriate requests will be granted and the pupil noted as an authorised absentee in the register.

EQUAL OPPORTUNITIES AND SOCIAL JUSTICE

In St. Joseph's Primary School all children experience equality of opportunity. We expect the same standards of behaviour and work from girls and boys.

EARLY YEARS/NURSERY CLASS

The school has a nursery which provides a learning environment for young children. Parents from any area may apply to attend the nursery class. To find out more about the

nursery please contact the school. However, it should be noted that if you register your child for a nursery in a school this does not mean that they will automatically be enrolled at this school when they are ready to start primary school. All children who move from early years to primary education must register separately for school in the month of January.

St. Joseph's Nursery Class opened in August 2000 and can now accommodate 44 infants from 3-5 years. This is a term-time nursery, opening for morning from 9.15 am until 3.15 pm.

There are two nursery teacher – Mrs. MacKenzie and Mrs Kennan, five early years workers – Miss Tant, Mrs Smith, Mrs O'Hare, Mrs Magee and Miss Boyd and an early years team leader – Mrs Friel. ENROLMENT – HOW TO REGISTER YOUR CHILD FOR SCHOOL

If your child is starting school for the first time you must enrol your child at their catchment school in January. If parents want their child to go to another school, they must enrol in the first instance with their catchment school and ask for an information leaflet that provides details on how placing request. Forms are available from the SLC website make а to www.southlanarkshire.gov.uk, schools, Q and A offices or by contacting Education Resources, Almada Street, Hamilton, telephone 01698 454102. Completed forms should be returned as soon as possible to Education Resources, Almada Street, Hamilton ML3 0AE.

Enrolment date for 2020 is week commencing 13 January 2020.

INDUCTION PROGRAMME FOR INFANT BEGINNERS

It is important that our children feel happy and secure in our school. We want them to know their teachers and their new friends before joining Primary 1. We want to form a partnership with the parents from the time of enrolment. We will organise a series of 3 half day visits for children and parents over a period of 3 weeks in May/June, before starting Primary 1 in August. Fun activities are set for the children, led by the class teacher and other teachers in the school. Parents have the opportunity to work with their child and to talk with staff and each other over a cup of tea. Guidance will be given on how to best prepare our children for starting school.

TRANSFER FROM PRIMARY TO SECONDARY SCHOOL

Pupils normally transfer from primary to secondary school between the ages of 11¹/₂ and 12¹/₂, so that they will have the opportunity to complete at least 4 years of secondary education. Arrangements are made by the school to transfer children to the associated secondary school as determined by their home address. Parents of P7 children will be informed of the transfer arrangements made for their child to attend secondary school.

We will also provide you with information at this time and on events designed to let P7 children visit the secondary school, meet up with other P7 children from other schools so that the transition period is as smooth as possible.

Normally children attend the school in their catchment area. However, there are times when parents may wish their children to go to other schools. If you wish your child to go to another school then you may make what is known as a 'placing request'. If you live in South Lanarkshire and decide to submit a 'placing request', we are unable to reserve a place in your catchment school until the Council have made a decision on the 'placing request'. Please note if your 'placing request' application is unsuccessful and all places at your catchment school are filled you will be offered a place at the next nearest appropriate South Lanarkshire School.

Please note that if an application for a 'placing request' is successful then school transport is not provided.



If you move outwith your catchment primary school a 'request to remain form' must be completed. If you move outwith your catchment primary, this may affect your right to transfer to the associated Secondary School. Please note the secondary school is determined by the pupil's permanent home address and chosen denomination. Every school has an Improvement Plan, based on priorities as outlined by Education Resources but each school personalises this plan to show their own next steps towards improvement. Priorities for Improvement for session 2016 - 2017 are:

- Improve achievement and attainment outcomes in all establishments annually
- Implement key aspects of Curriculum for Excellence in all schools
- Implement key aspects of legislative duties prescribed in revised/new legislation
- Process Getting it Right for Every Child (GIRFEC)
- Increase involvement in lifelong learning for young people and adults
- Progress the key themes of self-evaluation and leadership in all establishments

Importantly the school has carefully planned next steps to give the best opportunities for children to improve standards in literacy, numeracy and health and wellbeing. These are detailed in the school Improvement Plan. A copy of is on display for all to see. Parents may, of course, request their own copy. The Improvement Plan has been discussed at Parent Council meetings and they represent the parent forum. Any of our parents are very welcome to attend any of these meetings.

Language and Literacy

The 'Oxford Reading Tree' reading scheme" is used in Primary One to Primary three and 'Literacy World' is the reading scheme used from Primary four to Primary Seven.

"At the primary stages, children are making very good progress in English and literacy. Almost all children are confident in reading and are able to discuss their personal reading preferences." (Education Scotland Inspection Report)

These schemes are designed to help teach both fiction and non-fiction reading, comprehension, language and writing skills and covers the range of genres.

Children are encouraged to express their ideas and findings both orally and in writing with attention given to the conventions of punctuation and grammar.

Our Writing Programme is used throughout the school to provide children with a wide range of writing opportunities.

"As a result of a whole school focus on story writing, most children at all stages are writing very effectively." (Education Scotland Inspection Report)

A structured spelling programme (Nelson Spelling) is used to complement the various levels of "The Reading Programme" at the primary four to primary seven stages.

"Jolly Phonics" is a structured phonics programme used at P1 stage. Jolly Grammar Programme is used at P2 to P3 stage. The school and class library are

used to teach reference skills and encourage children to develop an interest in good fiction.

Mathematics and Numeracy

The Mathematics Programme offers opportunities in Problem Solving and Enquiry, Information Handling, Number, Money and Measurement and Shape, Position and Movement through oral, practical and written work.

"All children value the increasing opportunities available to extend their mathematical skills through problem solving in real life contexts and outdoor learning." (Education Scotland Inspection Report)

The "Scottish Heinemann" resource is used in Primary 1- Primary 7. This is supported by other programmes of study to ensure that "all pupils experience a coherent, continuous and challenging programme of work".

Pupils progress through the programme according to their own experience and ability.



Social Studies, Science and Technology



Social Studies, Science and Technology aim to teach children about themselves and their local community as well as making them aware of their national heritage and the wider world. The content of the



school programme is designed to meet these aims as well as giving opportunities to develop through the programme a wide range of concepts and skills.

Our school programme is designed to help the children to learn about, to learn from and to respond to their environment by encouraging them to use their own experience adequately. The topics chosen contribute to a balanced view of the

environment and life through aiming to make the children more aware of themselves and others, through the study of communities past and present and through comparing natural with man-made environment in this age of high technology.

"At the primary stages, staff are ably supporting children to make links across their learning." (Education Scotland Inspection Report)

Expressive Arts

Expressive Arts has, as its main components, the studies of Music, Art, Physical Education, Dance and Drama. In teaching these subjects there is an obvious desire to improve skills but in addition we are concerned that in these areas children derive pleasure and are encouraged to develop an interest which eventually may extend into their leisure life.

"ABC" interactive music programme is used throughout the school. Children are encouraged to sing, make music, read music, listen to music and learn to appreciate a variety of musical stimuli. Primary Five pupils receive two ten week blocks of practical music from a music specialist. Junior/Senior

pupils are also given the opportunity of receiving instrumental tuition from a music instructor from St John Ogilvie High School. In Art, "Smart Art" is used in all stages. This programme offers opportunities not just in painting and drawing but also in modelling, three dimensional work and collage making.



At various stages in their school lives, the programme in Physical Education, offers experience in games, swimming and athletics.

The drama programme offers opportunities in role play and other activities to complement the spoken language programme.

The Dance programme encourages the children to be creative and to develop technical skills. They

have opportunities to perform and experience enjoyment.



Religious and Moral Education

Religious Education plays a very important part in school life. This is Our Faith" programme in conjunction with "Faith and Learning" is used to teach the doctrine of the Catholic Faith. "God's Loving Plan" is the main resource used for teaching moral and sex education, Primary 1 to 7. The school and the priest work closely together especially when preparing the children for the sacraments.

Health and Well Being

The children are taught to have a healthy respect for their bodies and to learn how to care for them by being clean, eating proper food and exercising. In P6 & P7 the dangers of smoking and the abuse of other drugs, including alcohol, is featured as part of our programme.

The breadth and balance of our education for our pupils encompasses the education of 'the whole child' enabling them to develop in knowledge and understanding, in skills and attitudes concerning themselves – their own self-awareness and self-esteem, and concerning others – inter-personal relationships and inter-dependence as well as independence.

"Children know the importance of being physically active, work well together in groups and teams, and participate in a wide range of activities which promote a healthy lifestyle." (Education Scotland Inspection Report)

Modern Language - 1+2 Languages

Spanish is taught to pupils in P 5, P 6 and P 7 and has now been introduced throughout the school. French is introduced in P 4 and this will begin a new modern language structure of children learning firstly Spanish and then French. The lessons are taken by our own specially trained teachers who are part of St Joseph's staff. The children enjoy learning the languages and about the culture of the countries.

Assessment

Teachers assess their children's progress on a daily basis by looking and considering what children do, make, write and say. In this way the teacher can plan the children's next steps in learning. Targets are set though personal learning planning and children discuss and select personal targets with their parents. Learning intentions are discussed in school with the teacher so that the children are fully aware of what they are going to learn and what they need to do in order to be successful.

More formal assessments of progress are made using previously agreed pieces of work. These, along with the teacher's professional judgement about his/her pupils' progress allow the teacher and pupil to agree the level they are working on.

The progress of all pupils is tracked by the Head Teacher and regular progress reviews with each class teacher helps the school to plan support for learning and to plan future learning.

Each teacher plans next steps in learning for individuals, groups and whole class situations on a daily, weekly and termly basis.

"Staff across the school are highly reflective and work hard together to do their best for all children." (Education Scotland Inspection Report)

ADDITIONAL SUPPORT FOR LEARNING NEEDS

"Staff are quick to identify and support any children who may be having difficulty with learning. They also respond sensitively and effectively to other factors which may affect learning, such as health problems or social and emotional issues." (Education Scotland Inspection Report)

Getting it right for every child, (GIRFEC)

Getting it right for every child, (GIRFEC) is a national policy and programme which is implemented in Lanarkshire. The Scottish Government introduced GIRFEC as a long term programme; it is relevant to each and every child in Scotland, and reaches across children's and adults' services in the public and voluntary sectors to ensure there is firm commitment and drive towards achieving better futures for all of our children and young people.

GIRFEC promotes key values in working with children and their families across all agencies and is based on core components which will help bring these values about. The programme calls for all workers in health centres and hospitals, nurseries, schools and leisure centres, family centres, social work services and housing offices, and in the community to work together towards changes in culture, systems and practice that will help all children and young people to grow, develop and reach their full potential. Every child is a Special Child and both individual and special needs arise. Not all children will progress at the same rate or have the same ability. Careful and continuous assessment of each child's progress will inform the teacher of his/her next steps in learning and of any particular needs. This, along with good communication with parents and with other agencies, where relevant, will help build a profile of a child. Special needs are supported appropriately whether a child is experiencing learning difficulties, special difficulties or where a child is of a higher ability.

The best person to support the child who is experiencing difficulty is the class teacher. A specialist learning support teacher visits the school on a weekly basis to advise teachers, supply resources and work with small groups of pupils.





Children experiencing severe behavioural or learning difficulties can be referred, with parental consent, to an educational psychologist who is qualified to assess attainment and needs as well as supporting class teachers to devise appropriate programmes of work. Parents are invited to work in partnership with teachers to support special needs and are



fully consulted with recommendations and decision making, in meetings and in review sessions when other support agencies are involved.

South Lanarkshire Education Resources have published a series of leaflets available which cover information for parents and carers about the Additional Support for Learning Acts. These are available through the school or on the South Lanarkshire Council website <u>www.southlanarkshire.gov.uk</u>.

The Additional Support for Learning Act; Requesting an Assessment; Planning for Learning – ASP; Planning for Learning – CSP; Transitions; Future Planning; Information for Parents and Carers about moving on from school.; Inclusive Education; ICT Assessment; Visual Impairment Support; Early Years Specialist Support; Independent Adjudication

Getting it Right for Every Child (GIRFEC) was promoted and endorsed by the Scottish Government at the Children's Summit in 2010. There is a commitment to ensure that your child has the best possible start in life and to improve outcomes for children and families based on a shared understanding of their wellbeing. Most children make their journey from birth to the world of work supported by family and the universal services of Health and Education. The Named Person in education helps to make sure that the child's wellbeing is developing. The school will let you know the named person for your child. This is likely to be the head teacher in a primary school and the pupil support teacher in a secondary. If you have any concerns you should speak to the Named Person who will work with you to address any issues and to ensure that your child gets any help needed at the right time.

ATTACHMENT STRATEGY FOR EDUCATION RESOURCES

Attachment – what we do to support children and young people

South Lanarkshire Council Education Resources is committed to improving outcomes for children and young people by creating emotionally supportive learning experiences in our nurseries and schools.

The Education Resources Attachment Strategy was launched in March 2019 and supports the action in the Getting It Right for Every Child in South Lanarkshire's Children Services Plan 2017-20 - 'Develop an attachment strategy and to inform training for staff working with early years to secondary aged children and young people on attachment-informed practice'.

What does it set out to do?

The aim of the strategy is to promote better experiences of attachment for South Lanarkshire's children and young people and to ensure that all education practitioners understand the importance of attachment and how positive relationships can make a difference to outcomes.

How can I find out more?

South Lanarkshire Council Education Resources have published a series of leaflets and posters for parents/carers which aim to share information on attachment theory and on how this can inform the ways in which we support children and young people.

These are available from schools and we have plans to make them available on-line.

EXTRA CURRICULAR ACTIVITIES



Pupils currently have the opportunity to take part in football, chess, athletics, orienteering, book 'n' blether, drama and singing and netball coaching sessions after school. There is Play Leader Training for P6 & P7 boys and girls. We have a newspaper club for P7 and various clubs led by our children. Instrumental tuition is provided by Mrs. Duffy and Mr Michael from St John Ogilvie High School.

"We love getting the chance to sing, dance and act – it helps with our confidence" (P6 pupil)

Children will have swimming lessons at Blantyre Sports Centre. There are opportunities for P1 - 7 children to take part in a range of lunchtime and after school activities throughout the year.

Each year P7 boys and girls have the opportunity for a residential experience.

"No one gets left out, we're all involved in something" (P6 pupil)

Each year there is normally a Nativity Play and Summer Concert. The School Band perform at local venues e.g. Nursing Home/Asda Blantyre/Hamilton and Royal Concert Hall In Glasgow

All children are encouraged to be involved in sports e.g. swimming, running.

It is Council policy that school accommodation be made available, as far as possible, outwith school hours for use by the community. Such use by groups, clubs etc. will be in accordance with approved letting procedures and enquiries should be directed to the area community education office or the area office.

At present community groups use the school in the evening for: -

Continuing Education (Meetings etc.) P.T.A. Parent Council

Music Tuition

Instrumental music lessons are offered to children in a number of primary schools across South Lanarkshire Council through our Instrumental Music Service (IMS). Tuition is offered (based on capacity) on a variety of musical instruments, for example brass, strings, percussion, guitar or voice. Participation in a programme of instrumental music study can help children develop as successful learners, confident individuals, responsible citizens and effective contributors. Children who participate in instrumental music through tuition are often offered opportunities to further develop their playing by participating in extra-curricular activities through bands, orchestras and other ensembles.

Parents/carers, who wish their child to receive instrumental music tuition are required to make an annual contribution which is currently £180 based on a minimum of 30 lessons per academic year. Following a musical aptitude/suitability assessment, pupils entering P4 or P5 may be offered the opportunity to study a musical instrument. Through Youth Music Initiative funding, these pupils are exempt from playing the annual contribution detailed above for **one** academic year. Thereafter the annual contribution will apply for each consecutive year.

HOME AND SCHOOL LINKS

The school is eager to maintain and develop links with parents on all aspects of school life. Parents are welcome to call at the school at any time during normal school hours, though a phone call in advance may be beneficial in ensuring that unnecessary waiting does not occur. Information and news of events concerning the school is disseminated to parents by letters brought home by the children.

Parents' evenings are held twice annually at which pupil progress can be discussed privately through the use of an appointment system. Public parental meetings are organised at various times to discuss with and give information to parents on a variety of curricular or religious issues.

The school plays an important role in the local community and has very close links with St. Joseph's Parish and associated organisations. In addition we enjoy good relationships with other local schools and churches, charitable organisations, youth organisations, sports clubs, the library, the community centre, environmental groups, nurseries, play groups etc.,

PARENTAL INVOLVEMENT

South Lanarkshire Council recognises the importance of parents as partners in the education of their child and has published a strategy entitled, 'Making a difference – working together to support children's learning'. Parents, carers and family members are by far the most important influences on children's lives. Children between the ages of 5 and 16 children spend only 15% of their time in school! Research shows that when parents are involved in their child's learning, children do better at school and throughout life. Parental involvement can take different forms but we hope you share the same aims and agree that by working together we can be partners in supporting children's learning. As a parents/carers we want you to be:

- Welcomed and given an opportunity to be involved in the life of the school;
- Fully informed about your child's learning;
- Encouraged to make an active contribution to your child's learning;
- Able to support learning at home;
- Encouraged to express your views and involved in forums and discussions on education related issues.

All parents of children at school are automatically members of the Parent Forum and are entitled to have a say in what happens at the school. Parents can also decide to form a Parent Council to represent them. Our school has a Parent Council and a copy of its constitution and what it does is available from the school.

What does the Parent Council do?

The school and the local authority are obliged to listen to what the Parent Council says and to respond to the issues raised. Parent Councils decide such things as :

- > how their Parent Council will be set up
- > what it should be called (Parent Council or other name)
- > what size it should be e.g. in a very small primary school, all parents could be involved (no limit on size)
- > who should be a member of the Parent Council (majority of members must be parents)
- > how parents can join and support the school
- > how they can work together with the school and pupils to support children's learning
- > when the most convenient time is to hold meetings
- > What will be discussed at meetings these might be topics such as school uniform, parking near the school, the school's anti-bullying policy, etc. However, it should be noted that a Parent Council cannot discuss issues attributed to individual pupils.
- > More interesting is how parents can play an active part in helping the school to take forward, Curriculum for Excellence.

Schools and establishments should be the first point of contact for parents who wish to discuss issues about their child. Our aim is to resolve issues at a local level. Education Resources wishes to promote liaison among schools, members of Parent Councils, parents/carers and with other services. We wish to provide advice and support to Parent Councils, parents/carers.

<u>REPORTING TO PARENTS</u> Reporting will be ongoing and comprise of a range of activities which can include children presenting their learning, newsletters, and ongoing oral discussions.

We will provide parents with reports so that you can see what your child is doing and how they are progressing. In addition, there will be parents' meetings which offer you the opportunity to discuss how your child's progressing and how you can contact the school if you wish further information. The school will offer you an appointment time so that you can visit in person to discuss your child's education.

Our 'pupil reports' will help you to get to know more about the curriculum which each child follows and will describe their strengths, achievements and areas for development so you know what encouragement and support you can give.

We welcome any comments or additional information from parents to help us provide the best possible education for your child.

SCHOOL UNIFORM



We ask all parents/carers to support the school by encouraging your child(ren) to adhere to the agreed dress code and the wearing of our school uniform. The wearing of a school uniform helps promote the identity of the school in the local community and helps create an ethos of sharing and pride in the school.

In addition, the wearing of a uniform helps towards increasing the protection of all pupils. The wearing of a uniform helps staff and the pupils to distinguish between who belongs to the school and those who may be visitors. This enables staff to approach and identify visitors more readily and helps in trying to offer a safer environment for pupils and teachers alike.

Equality of opportunity is an important aspect of the life of the school. Any proposals on the dress code and on what constitutes the school uniform will be the subject of discussion with the Parent Council and where appropriate consultation with parents, pupils and staff.

There are forms of dress which are unacceptable in all schools such as:

- the wearing of football colours
- clothing with slogans that may cause offence (anti-religious, symbolism or political slogans)
- clothing which advertises alcohol, tobacco or drugs
- clothing which can be deemed unsuitable in terms of health and safety grounds such as shell suits, combat style clothing, dangling earrings, loose fitting clothes particularly in practical classes
- articles of clothing that could be deemed to inflict damage on other pupils or be used by others to do so
- footwear that may damage flooring.

Boysnavy blue trousers, white shirt, navy blue pullover and school tie.

Girls.....navy blue skirt or pinafore, white shirt, navy blue pullover and school tie.

Navy blazers with the school crest are also available locally.

All children are advised to wear gym shoes, school polo shirt and shorts for P.E. in the interests of safety. Swimwear is required for Primary 6 & 7 on alternate years.

PROMOTING POSITIVE BEHAVIOUR

We make every effort to maintain a positive approach in encouraging a high standard of behaviour in our children. We do this by being an inclusive school, by concentrating on successes and by celebrating and rewarding achievement. We want every child to feel valued and to value every member of our school community. It is important to foster high self-esteem. The pupils are part of our whole team and they should feel that staff and pupils work in an atmosphere of mutual respect, to create and maintain a positive, safe and caring environment. We, staff and pupils, recognise our own rights and the rights of others. Positive feelings and attitudes are encouraged through talking together as, for example, in class 'circle time'.

Within this framework there has to be self-discipline and school rules. The pupils are involved in drawing up class rules and school rules and therefore should feel an ownership and commitment to them. However if rules are not adhered to then there will be sanctions imposed. Class teachers operate their own sanctions, within our agreed discipline policy, for minor incidents, but will refer a pupil to the Head Teacher or Depute Head Teachers if the breach in positive behaviour continues or in the case of a more serious incident. When a sanction is imposed it is after discussion with the child concerned and sometimes with other children who have been involved, so that an accurate picture can be built up and so that the child sees any resulting action as fair. Parents will be informed on these occasions at the discretion of the Head Teacher, and may be invited to meet with the teacher or Head Teacher to discuss the incident. Working together we can plan ways to support the pupil towards more positive behaviour.

It is the responsibility of staff within the school to ensure that parent council members, parents and pupils are involved in the creation of a positive school ethos that encourages good behaviour. Equally, the school whilst trying to promote positive behaviour must support young people should incidents or bullying occur. Parents have a significant role to play in working with the school so that teachers, parents and pupils know what is expected of them in trying to change the behaviour and attitudes that contribute to bullying behaviour.

Our approach is to create an environment where better behaviour will encourage better learning. The school, along with the support of parents, can work together to create a learning environment which young people can enjoy and feel safe.

Incidents of bullying should be reported to the school immediately so that each alleged incident can be looked at. Together we can work towards creating a safer school for children and staff.

In addition, a guideline (Management of Challenging Behaviour) has been produced to support all teaching and support staff and inform them of their roles and responsibilities in respect of dealing with the small number of children and young people who display challenging behaviour. Early identification is crucial so that intervention can be provided to support children and young people to help them address their issues and concerns. Staff training is provided to help develop the skills needed to respond to and manage challenging behaviour. A wide range of appropriate staff development opportunities has been developed for this purpose.

"At the primary stages, children are motivated and keen to learn. They answer questions enthusiastically and offer their views and opinions with confidence." (Education Scotland Inspection Report)

INCENTIVES TO PROMOTE POSITIVE BEHAVIOUR



Class teachers operate their own class reward systems, praise, prizes etc. to encourage good behaviour and work effort. School incentives are also in place to encourage our children. Each week a 'Star of the Week' is chosen by the class teacher and rewarded by the Head Teacher with a special certificate and surprise. At



any time a child may be sent to the Head Teacher for a 'Special Mention' for good work, being kind etc. They receive a special sticker for their collection sheet and a 'special mention' at assembly. Details of these and other achievements are displayed on 'Our Achievements' wall for all to see. Children can earn 'Golden Time' each week as a reward for positive behaviour and effort. This is up to 30 minutes spent on an activity of their choice.

HOMEWORK

The work of the class is shared with parents through homework pieces set by the teacher. Homework tasks can be used as extra practice of skills being developed by the children in school and to research information to bring to lessons. Sometimes particular tasks are set in agreement with parents, to help children with a difficulty in their learning or to help catch up with work missed. Parents will be informed when their child is regularly failing to do homework.

ATTENDANCE AT SCHOOL

It is important for the school to work with parents in encouraging all children to attend school. All absences from school are required by law to be recorded. Absences will normally fall under two categories – authorised or unauthorised absence. In cases where your child is unable to attend school parents are asked to:-

• if you know in advance of any reason why your child is likely to be absent from school, please tell someone at the school, telephone us or let us know in writing. Please also give your child a note on his/her return to school, telling of the reason for absence;

• notify the school first thing in the morning when your child is going to be absent. Let the school know the likely date of return and keep them informed if the date changes;

- inform the school of any change to the following :-
- home telephone number
- mobile number
- emergency contact details

• requests for your child to be absent from school to make an extended visit to relatives must be made in writing to the head teacher, detailing the reason, destination and duration of absence and arrangements for their continuing education. On these occasions the pupil will be marked as an authorised absentee in the register.



FAMILY HOLIDAYS DURING TERM TIME

Every effort should be made to ensure that your child attends school during term time. Please contact the school as soon as possible if your child is unable to attend school. Family holidays should be avoided during term time as this both disrupts the child's



education and reduces learning time. If holidays are taken during times when the school is open parents should inform the school in advance by letter.

If your child is taken on a family holiday during term time then in line with Scottish Government advice this will be classified as an unauthorised absence. However, in exceptional circumstances schools may register a family holiday during term time as an authorised absence when for example, parents are unable to obtain leave during the school holiday period.

Clearly, absence with no explanation from parents will mean that the absence will be recorded as unauthorised.

In our approach to raising attainment and achievement it is recognised that attendance at school is something that should be continuously encouraged. Parents/carers, children and the school all have a part to play in encouraging and stressing the importance of attendance at school.

ATTENDANCE/ABSENCE DATA

The Regulations setting out information that needs to be included in school handbooks have been amended. This year the handbook does not include data on budgeted running costs or attendance and absence information. Budgeted running costs will no longer be included and attendance and absence figures are to be published every second year.

SCHOOL MEALS / SCHOOL MILK

Children of parents who receive the following benefits are entitled to a free lunchtime meal for their child



• Income Support, Universal Credit (where your take home pay is less than £610 per month), Job Seeker's Allowance, Employment and Support Allowance (income related), Working Tax Credit and Child Tax Credit(where your income does not exceed £6,900 gross per annum as assessed by the HM Revenues & Customs), Child Tax Credit only (where your income does not exceed £16,105 gross per annum as assessed by the HM Revenues & Customs) or receive support under Part V1 of the Immigration and Asylum act 1999.

If you are in receipt of Housing Benefit and/or Council Tax Reduction from us there is no need for you to apply online, we will use the information we hold to automatically award free school meals (P4 to S6) and/or school clothing grants (P1 to S6) to eligible families.

We would encourage parents of children who are in receipt of any of the above benefits to take up this opportunity of having a meal provided for their child when they are at school. Arrangements are in place so that children who receive free meals are not singled out and we encourage all children to remain in school at lunch time.

South Lanarkshire Council also offers a free Breakfast service, the service runs from 8.15am to 8.45am each school day.

Healthy eating is something that the school supports and a range of meals are available at lunchtime that meet the Schools (Health Promotion and Nutrition) (Scotland) Act 2007 and the Nutrient Requirements for Food and Drink in Schools (Scotland) Regulations 2008.



The menu consists of a three course meal and all meals include fresh chilled drinking water and milk will be available for those pupils entitled to free school meals through the free school meal eligibility scheme at morning break or lunchtime. Milk is also available for purchase to those pupils wishing to buy at morning break and lunchtime. The children also have access to unlimited bread, salad and vegetables to supplement their meal. Pupils in: Primary 1 - 3 receive a free school lunch and Primary 4 - 7 meal cost is $\pounds 1.70$

Milk is available free of charge to all nursery age children and is provided by the establishment.

ALLERGIES

A significant number of children and young people in our schools will have allergies and it is important that parents keep the school fully informed on these matters.

Allergies can present in a variety of ways and can occur at any point in a person's life. Symptoms range from mild to severe. Children and young people known to have an allergy with moderate to severe symptoms will likely have a Health Care Plan drawn up by the NHS. This will detail symptoms and appropriate interventions.

It is vital that parents share this information with the school and continue to provide any updated information.

Where symptoms are mild and a Health Care Plan is not in place, parents should still continue to liaise regularly with the school on any new triggers, medications and actions required.

In all cases, our employees need to know your child's symptoms, treatments and any actions required to help prevent exposure to the allergen and minimise the risk of allergic reactions.

Employees in schools will receive training on allergies and will liaise with parents and NHS on any additional specialist training required.

In supporting children and young people with allergies, school employees will operate in accordance with South Lanarkshire Council's Safe Systems of Work / risk assessment and national guidance on the administration of medicines.

Section 5: Health and Safety



MEDICAL AND HEALTH CARE



Parents are requested to inform the school of any particular medical requirements their child might have. The Medical Examination of children is undertaken during each child's school life, normally in the first year of primary schooling, and then at ages 10/11 years and 13/14 years, by staff of the Lanarkshire Health Board. Parents may refer their child at other times to the

Clinical Medical Officer for examination or advice. Dental inspections are also carried out on a regular basis in primary schools, and parents are offered any necessary treatment for their children, although they may chose instead to go to the family dentist.

A child who is taken ill, or has an accident in school is taken to the Medical Room. If the matter requires it, parents are contacted, either by home telephone number or, if necessary, through the Emergency Contact notified to the school. If it is not serious, parents would be expected to make arrangements for the child to be collected or brought home. A serious accident or illness would of course, require summoning of medical aid - parents would be informed of this immediately.

It is vital that the school has a current emergency contact number for each child.

ADMINISTRATION OF MEDICINES

Your co-operation is asked for in ensuring that the utmost care is taken with regard to medicines being brought to school. There is a potential overdose problem with regard to the intended recipient of the medication and also a danger that another child might accidentally take a substance with adverse results. In the interest of health and safety you are asked to observe the following guidelines.

If at all possible please administer medicines at home.

If a child must receive medicine during the school day then try to arrange for a responsible adult to bring the medicine to school and administer it.



If neither of the above arrangements are possible and you wish a member of staff to supervise the administration of a medicine, please contact the office and complete appropriate form.

It is necessary to contact the headteacher if your child carries an asthmatic inhaler.

These guidelines are not intended to be unhelpful but sensible precautions intended to prevent potentially dangerous situations.





CHILD PROTECTION PROCEDURES

All staff in educational establishments in South Lanarkshire Council are required to receive an annual update and follow the advice and guidance contained within the Education Operating Procedures. All staff must also complete a Learn on Line Course "Child Protection in Education". The shared vision for Lanarkshire's children is: "all children and young people in Lanarkshire have the right to be cared for and protected from abuse and harm in a safe environment in which their rights are respected." All agencies will work together in a collaborative way to promote the safety and wellbeing of children and young people in Lanarkshire.

The Chief Officers and Child Protection Committees of North and South Lanarkshire Council's are the driving force for ensuring that agencies individually and collectively work to protect children and young people as effectively as possible.

The Council has a duty in law to report suspicions that a child has been abused or is at risk of harm, in terms of the Children (Scotland) Act 1995. Therefore, Council staff have a professional and contractual obligation to report concerns to the head of establishment or the child protection coordinator immediately.

Education Resources staff and visitors from other agencies and services are required to follow these Child Protection Procedures to protect and support children and to fulfil their professional obligations to report all allegations or suspicions of child abuse.

For more information, or if you have a concern of a child protection nature, please contact the head of the educational establishment which your child attends.

TOWARDS A SAFER SCHOOL

St. Joseph's Primary School places a strong emphasis on pupil safety and parents may wish to know that an adult presence is provided in playgrounds at break times in terms of the Schools (Safety and Supervision of Pupils) (Scotland) Regulations 1990.

Section 6: Transport <u>TRANSPORT</u> General

School transport

South Lanarkshire Council has a policy of providing school transport to primary pupils who live more than one mile by the recognised shortest walking route from their catchment school. This policy is more generous than the law requires. This means that the provision of transport could be reviewed at any time. Parents who consider they are eligible should obtain an application form from the school or Education Resources, Hamilton, telephone 0303 123 1023 or web <u>www.southlanarkshire.gov.uk</u>. These forms should be completed and returned before the end of March for those pupils starting the school in August to enable the appropriate arrangements to be made. Applications may be submitted at any time throughout the year and will be considered by Education Resources.

A paid privilege transport scheme is operated for mainstream school contracts where a pupil is not entitled to free school transport. Privilege transport will only be granted providing there is spare capacity on an existing school contract and will be from and to designated pick up and drop off points. Privilege transport will not be provided where a service bus is used on the school run. Any spare capacity will be allocated using agreed priorities. For more information on school transport contact Education Resources telephone 0303 123 1023.

Pick-up points

Where school transport is provided it may be necessary for pupils to walk a certain distance to the vehicle pick-up point. Walking distance in total, including the distance from home to the pick-up point and from the drop-off point to the school in any one direction, will not exceed the authority's distance limit for school transport.

It should be noted that it is the parent's responsibility to ensure their child behaves in a safe and acceptable manner while travelling in and alighting from the vehicle. Misbehaviour can result in your child losing the right to school transport.

Parents are asked to note that South Lanarkshire Council does not provide transport for those pupils who attend school via a placing request. Where there is a request to place a child under school age in a school within the local catchment area they may receive transport in line with the Council's transport policy.

Any information on transport appropriate to the school should be mentioned.





Children Attending St. Joseph's Primary School

At present transport is provided for two categories of pupils attending

St. Joseph's Primary School: -

- a.) Certain children from Priory Bridge area
- b) Certain children on medical grounds

At present the contractor, S & H, operate a service for the children from Priory Bridge/Buller Crescent/Calderglen area. The children are normally supervised coming off and going onto the bus before and after school.

Information to proposed transfer of school

Children and young people may transfer school for a number of reasons such as families moving house, parental choice etc.

If you are proposing a change of school for your child please provide as many contact details as possible in relation to the new school so that we can ensure a smooth transfer of information relating to your child.

This will help us all to ensure the continued wellbeing of your child.

Section 7: Other Information INFORMATION IN EMERGENCIES



We make every effort to ensure the school remains open during term-time for pupils.

However, on occasions circumstances may arise which can affect the school. Schools may be affected by, for example, severe weather, power failures or through any other circumstances that may impact on the school day. In such cases we shall do all we can to let you know if this happens. We shall keep you in touch by telephone, text, where appropriate, letters, web news and through local radio stations particularly if there are prolonged periods of sever weather. The Council's website <u>www.southlanarkshire.gov.uk</u> will be used to let you know if the school is closed and when it will re-open.

It is important for parents/carers to let the school know of any change to your mobile/home telephone number and change of address.

Your commitments

We ask that you:

- support and encourage your child's learning
- respect and adhere to the schools policies and guidance
- let the school know if you change your mobile/telephone number and/or address
- enjoy and take part in school activities
- accept your responsibility to respect staff who work in the school and for the school to be proactive in taking forward it's commitment to care for and educate your child.

INSURANCE FOR SCHOOLS - PUPILS' PERSONAL EFFECTS

South Lanarkshire Council is concerned at the level of claims being received for loss or damage to pupils' clothing or personal effects. Parents are asked to note the Council's position in terms of insurance for pupils' personal effects:

(i) Theft/loss of personal effects

The Council is not liable for the loss or theft of pupils' clothing or personal effects for example mobile phones, tablets etc. and any items are therefore brought into the school at the pupil/parents' own risk.

Parents can assist by ensuring that valuable items and unnecessarily expensive items of clothing are not brought to school.

Teachers and other staff have been advised not to accept custody of any such items.

The same principle applies to musical instruments and other equipment used for activities within the school, which belong to the pupil, but are brought into the school. Parents should be aware that if such equipment is left in school, it is done at the pupil/parents' own risk.

In the case of valuable items such as musical instruments, parents should ensure that these items are covered by their own household insurance.

(ii) Damage to clothing

The Council is only liable for damage caused to pupils' clothing where the damage has resulted from the negligence of the Council or one of its employees. Claims arising otherwise will not be accepted by the Council's insurers.

General Data Protection Regulation as supplemented by the Data Protection Act 2018 (GDPR)



Information on pupils, parents and guardians is held by the school to enable the teaching, registration and assessment of pupils as well as associated administrative duties. The information is stored and used as per the requirements of the GDPR, with South Lanarkshire Council defined as the data controller. The Council have established a data protection policy that applies to all of its school.

Education Resources has also prepared a privacy notice (below) which sets out how we will deal with personal information as part of our statutory function as an education authority. For more information please contact the school.

Privacy Notice

Introduction

The Council has a legal obligation to deliver effective education services to children, young people and adult learners in South Lanarkshire. In order to do this we need to collect personal information about children, young people and their families so that we can help them to learn and keep them safe.

Using your personal information

The Council is a "controller" of the personal information you provide when enrolling for a nursery or school, applying for an education service or participating in groups or activities provided by Education Resources.

Information we collect from you about you and your child at enrolment

When you enrol for a nursery or school, we ask for the following information:

- parent/carer contact details (name, address, phone, email);
- the child's name, date of birth, gender and address;
- information about medical conditions, additional support needs, religion and ethnicity;
- any information you may wish to provide about family circumstances.

Information we collect at other times

We will also collect information at other times such as when you apply for a benefit, request a services or other support. We will provide an additional privacy notice at these times.

- When you apply for an education service or benefit, such as school transport, free school meals, clothing grant, placing request or EMA, we will also ask for personal information as set out above. We will also ask for information about your income for education benefits applications.
- If you make a request for additional support such as an educational psychologist or other support for learning we will ask for more detailed information to allow us to provide the most appropriate support for your family. This may include information about family circumstances or medical conditions.
- If you wish to participate in activities or support for young people through our youth centres, or through adult learning programmes within the community, we will also ask for your personal information to support your application. This may include information about family circumstances or medical conditions.

We require this information to ensure that children and young people are educated appropriately, supported, and that we take account of their health and wellbeing. We will also ask you to update this information annually and to tell us when there are changes to your details.
Information that we collect from other sources

As an education authority and as part of our statutory function in accordance with our legal obligations, we receive information from other sources such as the SQA, the NHS or Social Work about you or your child, this includes:

- exam results and assessment information;
- information about health, wellbeing or child protection.

Why do we need this information?

We need this information so the Council can ensure it is delivering education services appropriately to all learners:

- for the education of children, young people and adult learners;
- for teaching, enrolment and assessment purposes and to monitor the educational progress of children, young people and adult learners ;
- to keep children and young people safe and provide guidance services in school;
- to identify where additional support is needed to help children, young people and adult learners with their learning;
- to maintain records of attendance, absence and behaviour of children and young people (including exclusions);
- to support children and young people moving on each year from nursery to primary, primary to secondary and when they move or leave school;
- to help us develop and improve education services provided for young people, adult learners or families
- In accordance with our legitimate interests as an education authority we will also use your information to create statistical reports.

We will share your information with:

As an education authority and as part of our statutory function in accordance with our legal obligations we will share information with other bodies or parts of the Council, including:

- The Scottish Government and bodies such as Education Scotland, Scottish Qualifications Authority, Skills Development Scotland and other organisations that support children and young people's learning;
- Other parts of the Council when required for services such as school meals, school transport, education benefits and with Social work in connection with any child protection concerns we become aware of;
- South Lanarkshire Leisure and Culture Limited, where children and young people are participating in sports and leisure activities;
- Other schools/local authorities if a child moves or transfers to another school the Council has an obligation to pass on information with regards to pupil records to the new school/local authority.

You have the right to access your personal information as well as the rights of rectification, erasure, restriction and the right to object. MULTI-STAGE (COMPOSITE CLASSES)

"Multi-Stage or Composite classes consist of pupils who entered primary at different dates. Usually there are two single stages represented in a composite class but it is not uncommon, especially in rural areas, to have more than two stages represented. The range of attainment in a composite class is likely to be similar to that in a single-stage class since groupings will have been made on the basis of educational attainment across the different stages represented.

Composite classes are normally formed on the basis of language and/or mathematics working groups. This means that pupils working broadly at the same pace and level in language and/or mathematics are grouped together.

The above statement sets out the South Lanarkshire position on composite classes. Composite classes will contain no more than 25 pupils.

Composite classes are formed in St. Joseph's when they are a numerical necessity and it would appear that they will feature prominently in future arrangements for the foreseeable future.

Staff will give every care and attention to ensuring that class organisation facilities are conducive to appropriate learning and teaching.

A booklet on "Classroom Organisation" has been produced by South Lanarkshire Council and is available on request from the school.

INTEGRATED CHILDREN'S SERVICES

Education Resources is a key partner in developing an approach which promotes the delivery of better integrated services to children, young people and their families.

PARENT-TEACHER ASSOCIATION

The mission of the Catholic school is to develop as a community of faith and learning, providing the highest quality of education, and offering formation through the promotion of Gospel values, through celebration and worship, and through service to the common good.

All Catholic schools in Scotland, in honouring Jesus Christ as the Way, the Truth and the Life, will feature the following characteristics:

- a commitment to the integrated education and formation of the whole person, in close partnership with parents as the first educators of their children;
- an inclusive ethos which aims to honour the life, dignity and voice of each person, made in the image of God;
- a commitment to the search for wisdom in life and to the pursuit of excellence, through the development of each person's unique God-given talents;
- a commitment to the spiritual formation of the school community, through the shared experience of prayer and liturgy, and in partnership with local parishes;
- the provision of religious education programmes which will enable young people to develop their understanding of Gospel values and of how to apply them to life;
- a commitment to uphold the moral teaching, faith tradition and sacramental life of the Catholic Church;
- a commitment to communicate Catholic social teaching and thereby to promote social justice and opportunity for all;
- a commitment to ecumenical action and the unity of Christians;
- the promotion of respect for different beliefs and cultures and for inter-faith dialogue;
- a commitment to support the continuing professional and spiritual development of staff.
